The comment period has been extended to January 9, 2004

The program is administered by states and may be used for urbanized, small urban and rural areas under the Nonurbanized Area Formula Program to provide public transportation assistance. The FTA reviews applications for eligibility and compliance. Reporting requirements by the state and agencies allows the FTA to monitor projects and develop annual reports.

## **Department of Transportation Issues Revised Final Rule on Disadvantaged Business Enterprise Program**

This final rule revises the Department of Transportation's regulations for its Disadvantaged Business Enterprise (DBE) program. It makes several changes to the DBE program, concerning such subjects as uniform application and reporting forms; implementing a memorandum of understanding (MOU) with the Small Business Administration (SBA); substantive amendments to provisions concerning personal net worth, retainage, size standard, proof of ethnicity, confidentiality, proof of economic disadvantage, DBE credit for trucking firms, and eligibility of firms owned by Alaska Native Corporations (ANCs); and clarifications concerning multi-year project goals and the use of the new North American Industrial Classification System ("NAICS").

## ADMINISTRATION PROPOSAL SUBMITTED:

**SAFETEA is out of the bag. And it has good news for rural transit.**

Continuing the promise in the President's FY 2004 transit budget to increase rural transit spending, the Administrations newly released ISTEA reauthorization bill, the Safe, Accountable, Flexible and Efficient Transportation Equity Act of 2003 (SAFETEA), would increase the nation's investment in rural transit by around 20 percent.

Released May 14, 2003, SAFETEA formally begins the dialog, bargaining, praising, complaining and negotiating over the terms of continuing ISTEA which expires the end of September 2003.

Rural (Other than Urbanized - 5311) funding authorizations in SAFETEA would increase from \$359 M in 2004 to \$402M in 2009. Two percent of that would be distributed by formula to the Rural Transit Assistance Program (RTAP) of which not more than 15 percent may be available for the National RTAP program.

FTA Administrator Jenna Dorn explained that five principles provide the framework for the transit aspects of the bill:

- Adequacy of resources,
- Predictable funding
- Local flexibility
- Federal government as partner to get results
- Serve the vulnerable populations.

Some key language in the Public Transportation Formula Grants for Special Needs of Elderly Individuals and Individuals with Disabilities released by the Department of Transportation when the President's proposal for reauthorization of TEA-21 (SAFETEA) was unveiled is that eligibility requires that "projects be selected from a locally developed coordinated public transit-human services transportation plan."

Funding authorizations would start at \$87M in 2003 and top at \$97M in 2009. (Authorizations are recommended levels, not the actual appropriations which take place each year). For more details download the [fact sheet](#).

Through this initiative CDOT provides funding and technical assistance to Colorado transit properties to help bolster their marketing efforts. The aim of TVP is to move participating transit agencies' promotional programs to the next level, enabling them to have a greater impact on the communities they serve.

### **FTA Releases FY 2003 Apportionments, Allocations and Program Information**

The Omnibus Appropriations Bill "Consolidated Appropriations Resolution, 2003", (Pub. L. 108-7) was signed into law by President Bush on February 20, 2003, which includes the Department of Transportation and Related Agencies Appropriations for fiscal year 2003 (FY 2003 DOT Appropriations Act), and provides FY 2003 appropriations for the Federal Transit Administration (FTA) transit assistance programs.
