NCHRP Report on "Availability & Accessibility of Liability & Excess Insurance for Public Transit & Private Coach Operators"

The National Cooperative Highway Research Program recently completed a report entitled, "Availability & Accessibility of Liability & Excess Insurance for Public Transit & Private Coach Operators". This report was finished as part of the work plan for the AASHTO Standing Committee on Public Transportation. FTA Releases Guidance on Private Sector Participation

The new FTA brochure, "Private Sector Participation" is intended to be a user-friendly guide to private sector involvement for use by planning agencies, transit agencies, and private transportation providers. The brochure explains in plain English how and why private sector providers can be involved in delivering public transportation services. It also discusses the requirements for private sector involvement in Federally-funded transportation programs, from the early transportation planning stages to service delivery.

FTA Releases Guidance on Head Start Regulation

As part of United We Ride, the Federal Transit Administration (FTA) is working closely with federal partners to identify opportunities to improve coordination of services. On January 18, 2001, the Head Start Bureau, a federal

agency within the U.S. Department of Health and Human Services, issued detailed regulations concerning the transportation of children within its programs (45 CFR Part 1310). Full implementation is targeted by **January 18**, **2006**.

This regulation, under 45 CFR part 1310.10, states that each agency must assist as many families as possible who need transportation in order for their children to attend the program in obtaining that transportation. Agencies have the option of providing transportation services either directly or by contract, or providing reasonable assistance to Head Start families to arrange transportation to and from its activities.

FTA has drafted an <u>overview</u> to provide clarification regarding use of FTA funds to purchase vehicles that may be used to transport Head Start participants as well as other riders in a coordinated system.

FTA Emphasizes United We Ride

<u>United We Ride</u> -- a new five-part initiative-- to break down the barriers between programs and set the stage for local partnerships that generate common sense solutions and deliver A-plus performance for everyone who needs transportation.

The <u>United We Ride</u> initiative includes:

- A Framework for Action. Created by a panel of experts from around the country that convened in August 2003, this publication is a self-assessment tool that States and communities can use to identify areas of success and highlight the actions still needed to improve the coordination of human service transportation.
- <u>State Leadership Awards</u>. These initial awards have recognized a select number of States that have accomplished significant progress in human service transportation coordination.
- National Leadership Forum on Human Service Transportation Coordination. This conference, held in late February 2004, brought together Governor appointed senior leadership teams seeking to raise the visibility of the issue among State leaders and secure commitments to action. The forum was used to provide technical assistance, as well as to recognize those States that have already taken significant steps to improve human service transportation services.
- *State Coordination Grants*. States participating in the United We Ride National Leadership Forum will be eligible to submit an application for State Coordination Grants, to address gaps and needs related to human service transportation in their geographic regions.

• *Help Along the Way.* This ongoing technical assistance program will build on the work of the Community Transportation Assistance Program (CTAP), the Rural Transportation Assistance Program (RTAP), Easter Seals Project ACTION and other stakeholders to provide handson assistance to States and communities in the development and delivery of coordinated human service transportation programs.
